3. **Schedule** your online payment using your checking or savings account.

When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic fund transfer from your account or to process the payment as a check transaction.

One- and two-family dwellings are only required to register annually where neither the owner nor any family member occupies the dwelling.
